#### ACTION

#### I OPENING OF THE MEETING

- 1 M Fougerousse opened the proceedings. The programme had been changed to allow full discussion on the important decision to be made about the future of the IRG Secretariat.
- 2 The agenda was approved.
- 3 Apologies for absence had already been noted.

#### II APPROVAL OF THE MINUTES

4 The minutes of the last meeting were approved without alteration. All the matters arising had been noted in the agenda.

## III PROGRESS OF THE WORKING GROUPS

5 The President said that the programmes of the Working Groups were progressing well and could be formally approved. (Details are given in Documents IRG/WP/168, IRG/WP/295, IRG/WP/3103 and IRG/WP/436.)

## IV VENUE FOR THE 1978 MEETING IN SCOTLAND

6 The Secretary announced that the Peebles Hotel Hydro, Peebles, Scotland, a conference hotel about 23 miles south of Edinburgh, had been booked for 18-22 September as the venue for the 1978 meeting. Transport would be provided from Edinburgh Airport for delegates travelling from abroad.

## V VENUE FOR THE 1980 MEETING IN USA

- 7 The President reminded members that no meeting would be held during 1979, but the Group would meet in the spring of 1980 in the USA.
- 8 The Secretary noted the date of this meeting would be 5-9 May 1980, the venue being the University of North Carolina at Raleigh.
- 9 G B Fahlstrom confirmed that arrangements had been made for IRG members attending the American Wood-Preservers' Association Meeting during 27-30 April 1980 in Nashville, Tennessee, to be transported from Nashville to Raleigh by motorbus. The bus transportation would be provided by the University, but the costs of a necessary overnight stop would have to be met by the individual. He hoped that all members
